Plots are allocated by Waiting List (for 6-year member plots) to CCRA Resident Members, and by lottery (for 1-year lottery plots) to non-member Residents.

- Eligible non-current gardeners may request their name be added to the Waiting List by emailing [centercity@centercityresidents.org](mailto:centercity@centercityresidents.org).
- If you are in your final year of your 6-year member plot, you may put your name on the Waiting List on or after May 1 of your final year in the garden by emailing [centercity@centercityresidents.org](mailto:centercity@centercityresidents.org).
- A non-CCRA member gardener who was awarded a one-year lottery plot and thereafter joins CCRA may place his or her name on the Waiting List by emailing [centercity@centercityresidents.org](mailto:centercity@centercityresidents.org) at any time after joining CCRA.
- The name(s) on the Waiting List must include all parties residing at the CCRA membership address. You may not have a plot in your name and be listed on the Waiting List in the name of anyone else at your address.
