Parkside Plantings: Allison reported that the compost was put down around the plantings and seems to be working fine and is not burning the plants. The fencing has been removed from the trial section of the border and signs with Do Not Trespass were put that section. Unfortunately, the signs were stolen.

Grievance Committee: The Grievance Committee sent out their response and has not received back any comments.
